When the 15th falls on a Saturday, Sunday or legal holiday, payment is considered timely if made on or before the next succeeding day that is not a Saturday, Sunday or legal holiday.

If you estimate that you will owe at least \$200.00 in municipal income tax (after subtracting your estimated withholding and credits), you should make quarterly estimated payments. You may be charged penalty and interest if you fail to timely pay quarterly estimated payments totaling at least 90% of the current tax year liability or 100% of the prior year tax liability.
